# Royal College of Psychiatrists' briefing CQC ratings of NHS mental health trusts 2 September 2022

The Care Quality Commission (CQC), which regulates service quality across health and social care, commenced reporting of 'Ofsted-style ratings' for providers from 2014. This document, subject to regular updates on our Mental Health Watch website, will illustrate the state of play for all 50 mental health NHS trusts and foundation trusts.

#### What are the areas covered in CQC inspections?

Each provider of mental health services is rated against five overarching questions to determine an overall rating from the CQC. Among the issues covered under 'key lines of enquiry' for NHS trusts and foundation trusts are the following:

- Is it safe?
  - o Medicines management
  - o Risk assessment
  - o Learning from errors
  - o Safeguarding

### • Is it effective?

- o Needs assessment and provision of evidence-based care
- o Outcomes measurement and benchmarking
- o Staff capability
- o Collaboration between staff, teams and services
- Is it caring?
  - o Dignity and respect
  - o Compassion towards patients
  - Upholding privacy
  - o Patient involvement in decision-making

### • Is it responsive?

- o Prompt access to treatment and support
- o Provision of person-centred care
- o Complaints handling
- o Adapting care to needs of different groups
- Is it well-led?
  - o Leadership capacity and capability
  - o Organisational culture
  - o Management and governance
  - o Learning and innovation
